CENTRAL OREGON PET CARE PROS will be referred to as Pet Care Pros within this document. Client, Customer, Pet Owner will be used here to refer to those who sign and date this agreement and the Custom Care Pet Contract.

- A signed **Custom Care Pet Contract and Central Oregon Pet Care Pros Contract** documentation must be provided to your pet sitter before initial service is provided.
- Pet Care Pros works 365 days a year with daily work hours of 7am – 9pm.
- We provide an initial free site consultation where we become familiar with your home and your pets. Here we learn their routine and make sure they are comfortable with us. We also review our contract and Custom Care Pet Contract and receive a key to your home.
- Key Pick-up/Drop-off – If you prefer to have the key returned/picked up before each set of visits there is a \$10.00 fee per each stopover.
- Clients will call Pet Care Pros call upon arrival home. Pet sitter will return for additional visit and the client will be charged accordingly until client calls Pet Care Pros at their business phone line 541.480.3596 to acknowledge they are home.
- **Price Breakdown:**
 - \$20.00 – ½ Hour Visit (up to 4 visits per day available – no limit on pets).
 - \$70.00 - Overnight Charge (pm visit – night stay – am visit).
 - \$ 5.00 - Holiday Charge per each visit.
 - \$ 7.00 - Overtime Charge (15 minute increments).
 - \$ 5.00 - Late Night (after 9pm).
 - \$ 3.00 - Mileage Charge (10-14 miles).
 - \$ 5.00 - Mileage Charge (14-20 miles).
 - \$10.00 - Mileage Charge (21-25 miles).
 - \$20.00 - Transportation Fee.
- *Holidays observed by CENTRAL OREGON PET CARE PROS*
 - New Year's Eve Day - New Year's Day – Memorial Day – Fourth of July – Labor Day – Thanksgiving Day – Christmas Eve Day – Christmas Day.

- *Cancellation policies in acted by CENTRAL OREGON PET CARE PROS*
 - 24 hours prior to any service full visit fee will be charged for all scheduled visits within that time period
 - 72 hours required for holidays or ½ the cost of then entire trip will be charged.
 - 24 hours notice for returning home early or scheduled visit fees will be charged.

CENTRAL OREGON PET CARE PROS CONTRACT

- Invoice Payments: Payment is due within 2 weeks after a client returns home from a trip. Payments should be made out to CENTRAL OREGON PET CARE PROS.
- There is a \$25.00 service charge for returned checks.
- A \$25.00 late fee will apply to all billings not paid within 30 days of the invoice billing date.
- Client must pet proof home and yard. Pet Care Pros will not be responsible for pets with unsupervised access to the outdoors or free access outside of a kennel inside the home.
- Pet Care Pros is authorized to find emergency veterinarian assistance, at the cost of owner, if the vet specified by the client is not available.
- Client is responsible for keeping all supplies and equipment clean, reliable and readily available for pet sitter. Pet sitter is authorized to retain any supplies or tools necessary at the owner's expense to do job safely and professionally. (Food, collars & leashes, litter, can opener, etc.) Client will choose and leave the appropriate carpet cleaner, as the sitter will only use that product specified.
- Clients acknowledge that pet food dyes and natural pet body fluids can bleach and stain carpeting and are beyond the sitter's control.
- Clients should store valuables or sentimental items safely as a matter of problem prevention.
- Customer will be responsible for all medical expenses and damage resulting from; an injury to the pet sitter, other persons other animals and property by the client's pet.
- All individuals who will have access to the clients home while client is away must be posted for the pet sitter and reviewed with Pet Care Pros before service begins.
- Pet Care Pros is not responsible for damage to the home outside of the pet sitter's scope of work specified by the Pet Owner. If any damage occurs to your home Pet Care Pros will make every attempt to reach you first and then your emergency contact. Pet Care Pros will then make decision concerning the situation at hand. All fees and repairs will be paid by the client.
- Pet Care Pros is not liable for any damage or loss due to theft or other crime while working under contract. Pet sitter will secure the home to the best of their ability at the end of each visit. Keys will stay in the possession of the pet sitter or stored in a secured location specified by Pet Owner.
- Pet Care Pros can not care for visiting pets that do not belong to the contractual Pet Owner. Each pet under Pet Care Pros supervision will need to be approved of and the Pet Owner will have to provide a completed contract for that pet.
- This document covers all pets owned by the client presently and all new animals they obtain after date this form is signed
- Services Rendered In Future – Pet Owner states this contract as a valid approval for services by Pet Care Pros and for Pet Care Pros to accept all future telephone or email reservations and to enter their home without any additional written authorization.

- Pet Care Pros preserve the right to terminate this contract with notice at any time. If pet sitter determines client's pet poses a danger to themselves, other pets, the pet sitter or other persons, a phone call will be made to the Pet Owner informing them of this situation. At this time the Pet Owner will acknowledge the situation and make arrangements for the care for their pets immediately, releasing Pet Care Pros from their contract.
- Claims of negligence that surround the work of an Independent Contractor, retained by Pet Care Pros, will be the sole responsibility of the Independent Contractor and the company they represent. All Independent Contractors are required to have liability insurance and bonding.
- Pet Owner will direct all communication to Pet Care Pros in the event of communicating with a pet sitter.
- Pet Care Pros is operating as an assumed business name under the direction of HEATHER GOHDE PET CARE, LLC.
- Pet Owner agrees to contact Pet Care Pros immediately with any concerns.
- Agreement is valid from the date signed. Pet Owner agrees to any future changes made through mail, or email
- Pet Owner states they have read and understand the terms and conditions of this document.
